1 Summary

What

Discussions at Performance Assurance Committee (PAC) on confidentiality have shown that members of PAC need protection from legal action for their decisions taking when acting in good faith in accordance with their duties as members or alternate members of PAC. It seems sensible to reflect the provisions in Section X relating to members of Energy Balancing Credit Committee (EBCC).

Why

The change is needed to give members protection from legal action by Parties that are affected by their actions or decisions. Other UNC Sub-committees, with the exception of EBCC, do make decisions but these do not directly affect Parties and therefore it is desirable to give protection to PAC members to ensure that they do not feel constrained in performing their duties. This protection is limited to decisions made in good faith pursuant to members' duties. Not having this protection may mean that members do not make difficult decisions and thereby limit the effectiveness of PAC in delivering performance assurance.

How

New text will be inserted that mirrors the provisions in TPD X 1.2.7 and 1.2.8 relating to EBCC.

2 Governance

Justification for Self-Governance

The Proposer believes that Self Governance procedures should apply because this does not have a material effect on any of the relevant criteria.

Fast track procedures are not proposed, as this is not a house keeping change; although this change could have been made by modification 0506V this was not a requirement of the business rules and it is therefore not an error in the legal text of 0506V.

Requested Next Steps

This modification should be:

- · subject to self-governance
- proceed to Consultation.

It was proposed that this modification goes straight to Consultation as the legal text is exactly the same as the existing text in TPD X 1.2.7 and 1.2.8 with necessary changes being made to make it apply to PAC.

This issue was briefly discussed at PAC on 10th October 2016 where the Proposer stated that a modification maybe required. The draft modification was discussed at the PAC on 8th November 2016.

3 Why Change?

Members of PAC hold confidential information and may be required to make decisions that directly impact UNC Parties. It is important that they should be protected from liability claims made against them when they are carrying out their duties in good faith.

General Terms B 2.4.1 states "Nothing in the Code or a Framework Agreement or any Ancillary Agreement creates contractual rights or liabilities: [between any two Parties]"

However General Terms B 4.3.6 states "Members of a Sub-committee appointed to represent Users shall be appointed having regard to the contribution which they may as individuals make to the business of the Sub-committee and not to the Users by whom they are employed or engaged."

This makes it clear that members of PAC are appointed having the regard to the contribution they make as individuals.

In this respect PAC members are in a similar position to members of the EBCC. Members of the EBCC are protected from legal action by clauses in TPD X 1.2.7 and 1.2.8 which were presumably introduced to provide clarity and assurance for EBCC members and this modification proposes to give PAC members the same protection.

This should give confidence that members of PAC are protected from legal action by UNC Parties for decisions that PAC members and alternate members make when acting in good faith in carrying out their duties.

The legal text replicates that in TPD X 1.2.7 and 1.2.8 to be consistent with EBCC arrangements and to facilitate the speedy resolution of this issue to enable PAC to start fulfilling its functions as soon as possible.

Relevant objective (f) is facilitated as it promotes efficiency in the administration of Code by giving members of PAC confidence that they have protection from legal action when they carry out their duties.

8 Implementation

As self-governance procedures are proposed, implementation could be sixteen business days after a Modification Panel decision to implement, subject to no Appeal being raised.

9 Legal Text

Text Commentary

The text shown below is the text from TPD X 1.2.7 and 1.2.8 shown with strike outs and additions (in red) to show that the text is the same as that for the EBCC with only the necessary changes made.

The current legal text relating to PAC in TPD V specifically refers to DNOs, Shipper Users and Trader Users and this text retains this for consistency. Note that Independent Gas Transporters will be included after Project Nexus Implementation Date.

Legal Text

Insert new paragraphs 16.2.3 and 16.2.4 into TPD Section V

- 16.2.3 No member of the Performance Assurance Committee shall be liable (whether in contract or tort including negligence or otherwise) to any DNO or any Shipper User or any Trader User for anything done when acting properly in or in connection with his office under the Code, or anything done in what such member in good faith believes to be the proper exercise and discharge of the powers, duties, functions and discretions of that office in accordance with the Code; and each Transporter, Shipper User and Trader User waives any such liability that any such member may have and any claim in respect thereof.
- 16.2.4 Nothing contained in paragraph 16.2.3 shall exercise or limit the liability of a member of the Performance Assurance Committee:
 - (a) for death or personal injury resulting from the negligence of such member; or
 - (b) in any case where such member has in the exercise and discharge of its powers, duties, functions and discretions acted in bad faith or fraudulently.

Post Nexus Text

16.2.3 No member of the Performance Assurance Committee shall be liable (whether in contract or tort including negligence or otherwise) to any DNO or any Shipper User or any Trader User for anything done when acting properly in or in connection with his office under the Code, or anything done in what such member in good faith believes to be the proper exercise and discharge of the

powers, duties, functions and discretions of that office in accordance with the Code; and each Transporter, Independent Gas Transporter, Shipper User and Trader User waives any such liability that any such member may have and any claim in respect thereof.

16.2.4 Nothing contained in paragraph 16.2.3 shall exercise or limit the liability of a member of the Performance Assurance Committee:

- (a) for death or personal injury resulting from the negligence of such member; or
- (b) in any case where such member has in the exercise and discharge of its powers, duties, functions and discretions acted in bad faith or fraudulently.

10 Consultation

Panel invited representations from interested parties on 17 November 2016. The summaries in the following table are provided for reference on a reasonable endeavours basis only. It is recommended that all representations be read in full when considering this Report. Representations are published alongside this Final Modification Report.

Of the 7 representations received implementation was unanimously supported.

Please note that late submitted representations will not be included or referred to in this Final Modification Report. However, all representations received in response to this consultation (including late submissions) are published in full alongside this Report, and will be taken into account when the UNC Modification Panel makes its assessment and recommendation.

11 Panel Discussions

Discussion

The Panel Chair summarised that Modification 0603S seeks to provide confidence to PAC members that they have protection from legal action and can discharge their duties in good faith, thereby removing a potential barrier that may inhibit decision making and providing members with the freedom to act in the best interest of the GB Gas Industry.

Members considered the representations made noting that, of the 8 representations received, including one late representation, implementation was unanimously supported.

Members agreed with respondents and the Proposer that this modification would put in place an appropriate safeguard for the members of PAC who hold confidential information and may be required to make potentially unwelcome decisions that directly impact one or more UNC Parties, recognising that it is important that the members should be protected from liability claims made against them when they are carrying out their duties in good faith and acting on behalf of the industry.

Not having this protection in place may limit individual members' and, ultimately, the overall effectiveness of the PAC in agreeing and delivering the most appropriate performance assurance measures to be taken, as any decision making may then be compromised by reluctance to expose oneself as an individual (or severally) to potential liability.

Members agreed that it was appropriate to replicate the same assurances as currently afforded to the members of the Energy Balancing Credit Committee, noting that this offers a straightforward and effective means of providing the required protection.

Consideration of the Relevant Objectives

Members considered relevant objective f) *Promotion of efficiency in the implementation and administration of the Code*, agreeing that implementation would have a positive impact because the protections it affords supports effective decision making at the Performance Assurance Committee.

Determinations

Members voted unanimously to implement Modification 0603S.
