Section U: Operation of UK Link Committee

Certain User concerns were raised in respect of matters discussed in respect of UK Link Modifications but not fully reported. Transco agreed to convey these concerns to xoserve.

Section U: Modification Classes

Following a request at the March Workstream, Transco gave a presentation on the UK Link Modification Classes and associated processes. Members of the Workstream discussed how these processes were working in practice. It was agreed following discussion that the Workstream should set-up a sub-group to discuss the related issues in more detail.

Following discussion in the NT&T Workstream, this Workstream also discussed the manner in which Modification Proposals might be developed in Workstreams in the absence of specific terms of reference being set by the Modification Panel. Transco agreed to incorporate these views in the relevant guidelines.

The Workstream also noted that there might be a need to consider aspects of the Modification Rules e.g. multiple alternate Proposals that can be varied.
