Consultation on proposed amendments to the Data Assurance Guidance submissions for Electricity Distribution, Electricity Transmission, Gas Distribution and Gas Transmission Licensees. We seek your views before 18 January 2016 on proposed amendments to the Data Assurance Guidance (DAG) submissions for electricity distribution (DNOs), gas distribution and electricity and gas transmission licensees (TOs). For gas transmission the proposed changes are minor updates based on the changes of the regulatory reporting requirements. Uniform Network Code (UNC) 560: Addressing under-allocation of flows from BBL arisings from misalignment of reference conditions. UNC560 sought to correct an under-allocation of gas to shippers as a result of misalignment of reference conditions between BBL and the NTS. We approved this modification on 4 December 2015. Decision on the ex-post efficiency review on NGGT's Milford Haven pipeline project. We consulted on the ex-post efficiency review of the Milford Haven pipeline in July 2015. We have decided to maintain our funding arrangements as stated in our Transmission Price Control Review 4 (TPCR4) Final Proposals which maintains NGGT's project revenues reduction of £71m that was made in the TPCR4 Rollover in 2012/13.
