Electronic Data Catalogue' xoserve investigating documentation strategies and will report to August UK Link Committee

12494 'Addition of 'Prevailing AQ' and 'Prevailing EUC' to the info provided within the CSEP (CEP) Invoice'

Performance issues identified that present a risk to implementation. xoserve to report further.

11928 'Transco LNG Storage Communications'

xoserve investigating and will provide target date for this and other changes to the UK Link Manual to be implemented.

'Provision of Testing Services for Electronic Code Communications'. This is the subject of Uniform Network Code Modification Review Group 001 (formerly 0650). Meetings of the Review Group have taken place 16 June and 14 July 2005. If the Review Group recommendations are accepted this will be an ongoing topic at UK Link Committee.

'Replication and enhancement of Gemini API Functionality' xoserve analysis has been conducted and is to be reported to Transporters for evaluation, including classification.

'DPS file to include supplier start date'. This has been raised by EDF. The Transporters have indicated that it would not be classified as a Class 2 UK Link Modification.

Existing UK Link Modifications Approved:

- 11681 'Project Gemini Replacement of AT Link' A report on this project was submitted and discussed. With the exception of the downtime set for 17/18 October 2005, the June meeting agreed to the Implementation Plan. This last item was agreed at the July meeting.
- 13618 *'Network Code Reading Modification'*. Network Code Modification Proposals 0683, 0689 and 0690.

'Customer Transfer Programme' - Network Code Modification Proposals 0741 and 0742. *'Maximum Read Frequency'* - Network Code Modification Proposal 0693 Implementation Plan agreed, subject to consultation on minor file format change in respect of 0693 solution. It was clarified that shippers do not need to use new functionality prior to CTP in February 2006.
