UK Link Modifications Activity

The following Modifications have been referred to the Committee

Existing UK Link Modifications Awaiting Implementation Plan. Discussed within Committee:

12494 'Addition of 'Prevailing AQ' and 'Prevailing EUC' to the info provided within the CSEP (CEP) Invoice'

Analysis has been carried out on this UK Link Modification and the scope is being discussed between xoserve, on behalf of the Transporters, and Scottish Power - the originators of the change request. On the basis of the scope agreed, this will be undertaken as a Class 2 UK Link Modification.

11681 'Project Gemini – Replacement of AT Link'

A report on this project was submitted and discussed. Shipper Working Group meetings have been held and more are planned in June 2005. BP's recent change request 'Additional functionality to Gemini API' was discussed separately.

'Provision of Testing Services for Electronic Code Communications'. This is the subject of Uniform Network Code Modification Review Group 001 (formerly 0650). As part of the review process, a questionnaire had been issued. It was agreed that this would be re-issued for return by 31 May 2005. (Post meeting note – this action was completed 20 May 2005). A meeting of the Review Group to discuss the outcome of the questionnaire, which would be collated beforehand by Scottish Power, was arranged for 16 June 2005 immediately following the UK Link Committee Meeting.

Network Code Reading Modification'. Network Code Modification Proposals 0683, 0689 and 0690 were approved by Ofgem and implementation did not require any UK Link Modification. However, in order to improve the functionality of UK Link, the Transporters were expecting to

submit a plan to the June meeting for implementation in November 2005 – this would also include functionality to support the Customer Transfer Programme identified below.

'Customer Transfer Programme'. Network Code Modification Proposals 0741 and 0742 were approved by Ofgem and implementation did not require any UK Link Modification. It has also been established that no new transfer file was required (a file U11 had been discussed previously as a possibility).

There had also been some discussion on the issues at UK Link Committee and BP had raised Network Code Modification Proposal 0738 but this had been rejected by Ofgem. xoserve had already carried out a high level analysis and the implementation plan would be discussed at the June meeting.
