#### **Matters for Network Code Committee's Attention**

Draft terms of reference and process descriptions were discussed and a further draft is in preparation.

Members of the Network Code Committee may consider raising a Topic at the Governance Workstream to discuss a potential UNC Modification for setting up a User test environment.

## **UK Link Modifications Activity**

The following UK Link Modifications, referred to the UK Link Committee, were discussed.

#### **New UK Link Modifications**

13758 'Removal of Meter Asset at Dead Meter Points'

Following circulation of notice of this change and responses from System Users, the Committee agreed by consensus implementation of this Class 2 UK Link Modification for the November 2006 release.

13760 'Shipper Agreed Reads Procedural Change'

Following circulation of notice of this change and responses from System Users, the Transporters notified the Committee that a number of comments had been raised which they were considering and they were not at this stage seeking approval.

#### **UK Link Modifications Implemented**

'Rejection of Unmatched Gas Trades on Gemini

Following circulation of notice of this change and responses from System Users, this Class 1 UK Link Modification was implemented on 25 May 2006

#### **Topic Discussed**

004UKL 'UK Link Testing Arrangements'

The Transporters advised the Committee that they had identified set-up costs of £100,000 for a User testing environment. In addition there would be an additional cost in order to implement a test environment for each specific UK Link Modification. It was suggested that Users might wish to await progress on a UNC Modification, which would allow Users to progress a Class 3 UK Link Modification through the UNC consultation processes and then raise a UNC Proposal to initiate a User test environment. Prior to this, the Governance Workstream should consider raising a topic to progress discussions on a potential User testing Modification.

006UKL 'Gemini Performance Monitoring'

The Transporters advised the Committee that they would be updating the Committee on

progress with both the API response and the screen response aspect at the August 2006 meeting.

## 007UKL 'Release governance procedures'

The Transporters advised that they would be issuing a note to all Users proposing that contacts would be informed by email if there were any late changes in implementation plans and inviting them to submit names to be placed on the register.
