Modifications 0493, 0500, 0501 and 0510

Indicative Legal Text

1 Modification of UNC Introduction¹

The Introduction to the Code is amended by inserting in paragraph 2 a new sub-paragraph (e) as follows, and renumbering paragraphs (e) to (g) as (f) to (h):

"(e) the European Interconnection Document, which sets out provisions relating to Interconnection Points which differ from, or are additional to, the provisions of the Transportation Principal Document;"

2 Modifications of Transportation Principal Document²

2.1 *TPD Section A is amended by deleting paragraph 1.8.*

2.2 *TPD Section B is amended by:*

(a) deleting paragraph 2.1.15;

(b) deleting paragraph 3.1.11;

(c) deleting the whole of Annex B-3;

(d) deleting the whole of Annex B-4.

2.3 *The amendments in this paragraph 2 are effective with effect from the Gas Flow Day from which EID Section B is effective as provided pursuant to paragraph 5.2 below.*

3 Modifications of General Terms³

3.1 GT Section B

Amend GT Section B as follows:

(a) by inserting in paragraph 1.1.1, a new sub-paragraph (e) as follows, and renumbering paragraphs (e) to (g) as (f) to (h):

"(e) the European Interconnection Document;"

(b) by inserting in paragraph 1.1.2, ", European Interconnection Document" after "Independent Gas Transporters Arrangements Document"

(c) by inserting in paragraph 2.3.2(a), "and the European Interconnection Document" after "Transportation Principal Document".

3.2 GT Section C

Amend paragraph 2.1.2 to read as follows:

"a reference to a "TPD", "OAD", "IGTAD", "EID", "MR" or "GT" Section is a reference to a Section respectively of the Transportation Principal Document, Offtake Arrangements Document, Independent Gas Transporters Arrangements Document, European Interconnection Document, Modification Rules or General Terms;"

4 Addition of European Interconnection Document

The European Interconnection Document in the form attached as Attachment A is inserted as a new Document in the Code.

5 Modifications of Transition Document

5.1 Part A, paragraph 1.2 of the Transition Document is amended by inserting a new paragraph (d) as follows:

"(d) relating to the European Interconnection Document, which provisions are in Part V of this Transition Document."

5.2 The Transition Document is amended by inserting a new Part VA of the Transition Document in the form in Attachment B.

5.3 The Transition Document is amended by inserting a new Part VB of the Transition Document in the form in Attachment C.

6 Modifications of Ancillary Agreements

6.1 The IUK Ancillary Agreement is [modified (pursuant to TPD Section J paragraph 6.6.2) so as to be in the form in Attachment D1

6.2 The BBL Ancillary Agreement is [modified (pursuant to TPD Section J paragraph 6.6.2) so as to be in the form in Attachment D2

6.3 The Moffat Ancillary Agreement is [modified (pursuant to TPD Section J paragraph 6.6.2) so as to be in the form in Attachment D3
