## IMPLEMENTATION OF NON EFFECTIVE DAYS AND VARIANT NON EFFECTIVE DAYS FOR PROJECT NEXUS IMPLEMENTATION (PROJECT NEXUS TRANSITIONAL MODIFICATION)

## TRANSITION DOCUMENT, PART IIF – NEXUS IMPLEMENTATION

Add new paragraph 1.5 to read as follows:

## 1.5 Non-Elapsed Time Days and Non-TPD Communication Days

- 1.5.1 For the purposes of this Part IIF:
  - (a) where a Day is a "**Non-Elapsed Time Day**" then such Day shall not count as:
    - a Supply Point Systems Business Day for the purposes of TPD Sections G and M under the Old Rules and the New Rules;
    - a Query Count Day or a Query Receipt Day for the purposes of TPD Section S4.7;
  - (b) where a Day is a "**Non-TPD Communication Day**" then on such Day:
    - (i) a Party is not permitted to, and the CDSP shall not be required to, make any UK Link Communication for the purposes of TPD Section G;
    - (ii) a Party is not permitted to, and the CDSP shall not be required to, make any UK Link Communication for the purposes of TPD Section M

and accordingly the CDSP shall not be required to update the Supply Point Register on such Day;

- 1.5.2 Each Day in the period from (and including) 23 May 2017 to (and including) 5 June 2017 shall be a Non-Elapsed Time Day.
- 1.5.3 Each Day in the period from (and including) 23 May 2017 to (and including) 31 May shall also be a Non-TPD Communication Day.
- 1.5.4 For the purposes of OR TPD Section M5.2.2 and 5.2.3 no liability shall be payable by the Transporter by reason of the failure by the Transporter to provide a Valid Meter Reading on a Non-Elapsed Time Day.
- 1.5.5 A User shall not be entitled to notify an Invoice Query on a Non-TPD Communication Day.

Add new paragraphs 5.5.10. 5.5.11 and 5.5.12 to read as follows:

5.5.10 Subject to paragraph 5.5.11, for the purposes of this Part IIF where prior to the Implementation Date a Proposing User wishes to submit a Supply Point Confirmation specifying a relevant Proposed Supply Point Registration Date the reference to 14 calendar days in TPD Section 2.5.8(b) shall not apply, and the latest date on which the Proposing User may submit the Supply Point Confirmation shall be the date specified in the table below:

1, 2, 3, 4, 5 or 6 June 2017	17 May 2017

- 5.5.11 Where any of the circumstances in TPD Section G2.8.1(b)(i), (ii) or (iii) apply;
  - (a) for a Supply Point Confirmation specifying a Proposed Supply Point Registration Date of 31 May or 1 to 9 June 2017 (inclusive) the minimum notice period of four (4) Supply Point System Business Day shall not apply;
  - (b) a User may submit a Supply Point Confirmation after the latest date specified in the table in paragraph 5.5.10, subject to paragraph 1.5.2 and 1.5.3 and the minimum notice period of four (4) Supply Point System Business Day).
- 5.5.12 Where a Supply Point Confirmation is submitted on 20 or 21 May 2017 with a Proposed Supply Point Registration Date of 8 June 2017 the CDSP shall notify the Existing Registered User by no later than 13:00 hours on 22 May 2017 and the Existing Registered User may submit a Supply Point Objection by no later than 23:00 hours on the same day.
