<b>Reference</b>	<b>Topic</b>	<b>Explanation</b>
1.5.1	Definitions	<p>Introduces two new definitions:</p> <ul style="list-style-type: none"> <li>- <b>Non-Elapsed Time Day</b>; is a Day which does not count as Supply Point Systems Business Day, Query Receipt Day or Query Count Day; so where calculating a period of so many Supply Point Systems Business Days Non-Elapsed Time Days are ignored;</li> <li>- <b>Non-TPD Communication Day</b>, is a Day on which a Party (i.e. a User or Transporter) is not permitted to make, and the CDSP is not required to make, a UK Link Communication; in addition tthe CDSP is not required to update the Supply Point Register on any such Day.</li> </ul>
1.5.2	Which Days are Non-Elapsed Time Days?	Each Day in the period from 23 May 2017 to 5 June 2017
1.5.3	Which Days are Non-TPD Communication Days?	Each Day in the period from 23 May 2017 to 31 May 2017
1.5.4	No Liabilities	Dis-applies the Transporter liability connected with the provision of Valid Meter Readings in respect of Non-Elapsed Time Days.
1.5.5	No Invoice Queries	Users cannot submit Invoice Queries on Non-TPD Communication Days.
5.5.10	Supply Point Confirmations	Establishes a 'cut off date' for the submission of Supply Point Confirmations pre-PNID which have a Proposed Supply Point Registration Date falling in the period 1 June 2107 to 14 June 2017.

5.5.11	Supply Point Objections	<p>Where any of the circumstances in TPD Section G2.5.8(b)(i), (ii) or (iii) apply, i.e. 'non-competitive transfers':</p> <ul style="list-style-type: none"> <li>- the minimum 4 Supply Point Systems Business Days does not apply, so as to be consistent with the approach in paragraph 5.5.10;</li> <li>- subject to the rules on Non-TPD Communication and Non-elapsed Time Days, a User can submit a Supply Point Objection after the 'cut off date', subject to the normal 4 Supply Point Systems Business Days rule.</li> </ul>
5.5.12	Supply Point Objections	<p>Where a Supply Point Confirmation is submitted on 20 or 21 May 2017 with a Proposed Supply Point Registration Date of 8 June 2017 the CDSP will notify the incumbent User by 13:00 on 22 May 2017 and the User will have a short objection window, i.e. up until 23:00 on the same day.</p>
