UK Link Modifications Activity

The following UK Link Modifications, referred to the UK Link Committee, were discussed.

New UK Link Modifications

- 13717 'Financial Incentive Performance Regime of Resolution of USRVs (linked to UKL 13681)'
Following circulation of notice of change and responses from System Users, the Committee approved, by consensus, the plan for March 2006 implementation
- 13718 'Issue of M Number Disk in DVD-R Format'
Following circulation of notice of this change and responses from System Users, the Committee approved, by consensus the plan for July 2006 implementation
- 13723 'Introduction of a New Rejection Code OJT00018'
The Transporters gave notice that they would be issuing a notice on this change and suggested a November 2006 implementation date. Approval to be sought in April 2006 UK Link Committee for November 2006 implementation.
- 13725 'Single Central Online Gas Enquiry Service'
The originating change is within SPAA governance and the UK Link change arises from this. As it was agreed to be a Class 1 UK Link Modification the Transporters notified the committee that this had been approved and, subject to the decision of SPAA, would be implemented in November 2006

The Transporters notified the Committee that transaction times for Gemini API are expected to be included on the monthly report with effect from the June 2006 report. Transaction times in respect of Gemini screens were proving to be more complex and the Transporters will be updating the Committee on this aspect in due course.
