1. Introduction and Status Review

1.3 Ofgem Update

JT provided a general update, as follows:

- UNC 461: Changing the UNC Gas Day to Align with the Gas Day in EU Network Codes. The decision letter approves the change of the gas day to align with the CAM gas day definition. It also approves other UNC changes required to fully implement the new gas day. - Transmission networks: report on the performance of Transmission Owners during TPCR4 and TPCR4RO 2007-08 to 2012-13. This report summarises the outputs, incentives, Regulatory Asset Value, revenue allowances and company expenditure during TPCR4 and the subsequent rollover year. It also outlines the performance of the system operator companies, which provide balancing services to the entire gas and electricity systems. 3.1 Issues Register

LJ drew attention to the 3 outstanding entries on the Issues Register, noting that these had been on hold for some time:

0049: Gas Security of Supply Significant Code Review (SCR) Proposals: Credit Implications for the GB Gas Market – raised by Centrica

It was agreed that the originators should confirm if these could now be removed from the Issues Register.

Action TR0401: *Outstanding Issues 0006 and 0008* – Confirm if these can be removed from the Issues Register.

Action TR0402: *Outstanding Issue 0049* – Confirm if this can be removed from the Issues Register.

4.1 Systems Development Update (Xoserve)

4.2 Transmission Planning Code (TPC) Review 2014

In a short presentation RH outlined the background and gave an overview of the TPC. The last review had taken place in 2012, and a timeline illustrating the review process was displayed. The review will take account of recent industry developments and RH requested that any other identified areas/issues be notified to National Grid NTS by 25 April 2014 at Richard.hounslea@nationalgrid.com or ntsinvestment@nationalgrid.com

JCx asked how issues relating to PARCAs might be managed in the absence of a decision. EB indicated that two versions would be produced, one with and one without, with a potential ad hoc review of the TPC later. JT was unable to confirm any timescales for the Authority's decision on the two outstanding modifications; these were still under consideration.

RH reiterated NTS' willingness to engage with stakeholders to discuss any issues.

4.3 Industrial Emissions Directive (IED) and the NTS Compressor Fleet

EB gave a brief presentation, reporting that 17 compressor units were identified as being non-compliant with the IED. Various options for removing, mothballing, intermittent operating, and replacement, possibly with different capability, were under consideration to find the best option that would enable National Grid NTS to continue to meet its capacity release obligations.

Given the significant spend involved and the supply/Demand interplay with baselines, EB sought stakeholder views on industry engagement. JCx drew attention to studies on flexibility requirements. EB described various areas of flexibility and concurred that there might be some overlap.
