1. Introduction

BF welcomed all to the meeting.

2. Outline of Modification

SM introduced the modification. He explained that this adds a soft landing to Modification 0367, such that ratchet charges are not applied for the first 12 months. This is consistent with the approach taken elsewhere. This protects consumers who have no option but to see their status changed to firm on 1 October.

3. Consider Terms of Reference

No further comments were received on the Terms of Reference.

4. Discussion

The draft legal text was reviewed and it was agreed that it is clear.

SM questioned why there would be any costs to implement the change and presumed the approach used to suppress ratchets under DME could be adopted. Xoserve confirmed that no cost estimate was available at this stage but would be provided for the next meeting.

It was questioned whether a carve out would be needed for those who had already switched to firm and who, consequently, are subject to ratchets. It was clarified that there was no intention for the soft landing to apply only to those that change status on 1 October, but to all who are subject to regime change. SM agreed to check whether the modification and legal text needed to be modified to reflect this. SL suggested it might be better to refer to the date of implementation of the modification rather than 1 October in the legal text.

DW asked if there would be a risk that Shippers would do nothing in order to avoid being ratcheted. SM clarified that this was not the intention and he would ensure the modification is drafted to avoid this. The redraft would also exclude the elements that are common to 0367, focusing solely on the soft landing.
