#### 1.2. Review of actions from previous meetings

**Update:** Ofgem had indicated "that it would be most appropriate for this modification to be funded through the User Pays mechanism on the basis that provision was not specifically made for this expenditure under the current price control. This is supported by the arguments set out in the Gas Distribution Price Control Final Proposals Decision Document published in December 2007 (see page

#### 2.0 Discussion

A draft Workgroup Report had been published. TD made on-screen changes to the report to capture the views raised. It was noted that legal text is required to enable completion of the Workgroup Report. CW confirmed that he was happy that the wording within the solution section of the report was sufficient for National Grid Distribution to commence work on the legal text. However, whilst he believes that the legal text may be ready in time for the 10 October meeting, he would prefer to wait a little longer in case any alternative modifications are raised. TD noted that the Workgroup is required to report by the November Panel, such that the text is required irrespective of any alternatives that may be raised.

During discussion on the 2 day objection window rule, which is not addressed by the modification, Xoserve (AJ/LW) agreed to investigate the potential impact and implications of reducing from two to one business days. RS pointed out that the SMART project is currently discussing the change of supplier process reducing to a 1 day process.

Action 0004: Xoserve (AJ/LW) to investigate the potential impact and implications of reducing the objection window rule from two to one business days.
