BF pointed out that in order to gain maximum benefits from this modification, the Proposer had indicated that he would like the Workgroup Report to be submitted to the next UNC Modification Panel for consideration at short notice. BF then explained the process and timescales the modification might potentially follow. CC added that a 'minded to' view could always be sought from Ofgem to assist Shippers in the early recognition that appropriate preparations might be required.

The Workgroup raised no objections to the Proposer requesting the Panel to consider the Report at short notice.

The Workgroup Report was concluded, with the recommendation that the modification proceed to consultation.

The Workgroup Report will be finalised and submitted to the UNC Modification Panel on 15 December 2011.
