BF introduced the Workgroup.

2.0 Outline of Modification and initial discussion

DC introduced the modification, explaining the background and intent. He explained that the intention of NTS following SOMSA was to install their own equipment, however the installation of equipment/out-stations is questionable when the existing equipment could be used until the end of its life.

He explained the solution to install equipment only in certain circumstance to ensure the efficient use of existing equipment and to save reconfiguring sites. Where equipment would not be required the DN equipment could record the information and use the SCADA link to provide the information to NTS – this would present a significant saving to the industry.

BW asked National Grid NTS to recognise that DNs would need to configure systems to provide data to NTS and this would require additional administration and possibly longer notice periods. KG was aware there maybe some operational costs, BW recognised this would still cheaper than installing new equipment. It was agreed that notifications would need to be considered. DC would welcome an impact assessment for inclussion within the report.
