# 1. Review of Minutes and Actions

# 1.1 Minutes

The minutes of the previous meeting were accepted.

#### 1.2 Actions

**001:** Establish the maximum exposure with 100% take-up of the proposed arrangements

**Update:** DNOs had previously agreed to establish the national picture for exposure based on a worst case scenario. EM advised that SGN can only provide information for their networks and that information had been provided to Xoserve so that they could collate the national picture. GE challenged why a £0.5million code credit limit was used, he also questioned the limit to small supply points. SD explained an assumption had been made that if a company has a credit limit of £0.5million it was felt that they should be able to afford to fund their own credit arrangements without relying on the Transporters. SD

explained that the £0.5million was an estimated value and is open for discussion. The Workgroup discussed the potential discrimination that may result in setting limits or by applying a commercial judgement and in particular for those companies which fall outside the proposed arrangements. AM questioned if are any licence or UNC provisions which prevents a Shipper making a bilateral commercial arrangement with the Transporter(s).

It was agreed to leave the action open as more information was required on the potential level of take up from Shippers. **Carried Forward**.

**003:** Smaller Shippers to be approached and encouraged to provide view on the modification.

**Update:** SM confirmed that this had been put forward to Smaller Shippers forum to encourage their participation, he reported that there has been no immediate response to the modification. **Complete** 

**004:** Ofgem to provide a view of on undue discrimination. **Update:** TK confirmed that Ofgem were currently unable to provided an early view on the potential undue discrimination issue but would assess each modification on a case-by-case basis. **Closed** 

**005:** Ofgem to provide a view on the funding by the remaining participants funding if a shipper goes bust.

**Update:** TK confirmed that Ofgem would assess each modification on a case-bycase basis. **Closed** 

**006:** DNs to consider the modification costs and administration funding. **Update:** Pending business rules. **Carried Forward** 

# 2. Discussion

SM challenged the real benefit of the modification and there any support in the industry or Workgroup to progress development. He challenged the existence of the modification and whether the modification ought to be withdrawn.

Ofgem did not support withdrawal of the modification at this time. SD challenged the need for a modification if the process could be undertaken on an individual case-by-case basis through commercial arrangements. However, TK was concerned about equal treatment of parties if the provisions were excluded in the UNC.

It was agreed to contact smaller shippers and suppliers to encourage their views on the modification.

**New Action 007:** Gazprom to request feedback on the modification from the Smaller Supplier Forum.

**New Action 008:** Ofgem to seek feedback from the Proposer (Bill Bullen, Utilita) of Modification 0383 - Profiling payment of LDZ transportation charges.
