PH clarified that the methodology is referenced in UNC TPD Section J7.3, he confirmed the proposed changes to the methodology would be shared with the Workgroup. LH was keen to have sight of the changes to the methodology to aid the decision making process.

RCH believed that the modification had no impact to National Grid demand margin no investment required and give potential 'connectees' significant more comfort about commercial terms that would impact them.

PH asked if the Workgroup Report could document the changes that have been made to the modification to provide a background for the Panel to consider and explain the

rationale behind the amendments, the three options considered with an explanation as to the solution chosen. RCH agreed to add an appendix to the Workgroup report to provide some further developmental background.

A number of amendments to the Workgroup Report were discussed and captured for the proposer to consider.

Further consideration of the Legal Text was thought to be necessary around the OPN process.

It was agreed to publish a draft version of the Workgroup Report with the additional background information for approval on 01 July 2013. It was anticipated the Workgroup Report could be finalised in July.

Action 0502: National Grid NTS provide an updated Short Term Access to System Flexibility Allocation Methodology.
