## 1. Review of Minutes and Actions

#### 1.1 Minutes

The minutes of the previous meeting (23/07/12) were accepted.

#### 1.2 Actions

**0418 07/002:** Scotia Gas Networks (JM) to consider reporting asset related costs and energy related information using kWhs instead of SOQs.

**Update:** JM explained that he was unsure as to how utilising AQs rather than SOQs would actually work. After a brief discussion in which parties explained the rationale behind the action, JM explained that he believes that this action should be linked to Action 0418 07/003 below, and as a consequence, the DNs have given due consideration to the use of AQs within the modification, and do not propose to adopt this option. **Closed** 

**0418 07/003:** All Shippers to provide any information to justify using an alternative to flat rate allocation of asset related customer charge costs.

**Update:** JM confirmed that there had been no information forthcoming.

**0418 07/004:** Scotia Gas Networks (JM) to provide some analytical information using Option 3 (energy usage) to allocate asset related costs.

**Update:** JM indicated that he was uncertain how to actually undertake this action. It was agreed that this be closed. JM then provided an overview of the amendments undertaken in preparing version 2.0 of the modification, as

published on 19 October 2012. It was noted that ongoing work being undertaken within Project Nexus could have an impact on the modification.

TD noted that Ofgem had requested additional supporting evidence to make the case for change. JM advised that the DNs had considered this but had not been able to identify any further justification over and above that already provided.
