### 1. Review of Minutes and Actions

# 1.1 Minutes

The minutes of the previous 0379/0379A meeting were accepted.

#### 1.2 Actions

**1201:** Wales & West Utilities to provide 0421 (0379A) Legal Text for consideration. **Update:** RCH confirmed that WWU had provided the legal drafting which is available on the website and is being considered by the proposer. **Closed** 

**0302:** Xoserve (DA) to confirm the data on AQ performance extracted to support the proposed 0379A thresholds is accurate.

**Update:** DA reported that the AQ performance extracted was accurate. **Complete.** 

**0303:** Xoserve (AJe) to ascertain meter read performance in the context of 0379A and the proposed threshold.

**Update:** DA explained that the obligation of readings and summarised the key obligations. He provided some performance figures against the 90% target; for January 2012 74% of monthly read meters were read, for January 2011 95% of Annual read meters were read. MC questioned why the performance of monthly read meters was so low, GE explained that not all meter reads may have been loaded by Xoserve, however Xoserve also highlighted that some meter readings may have not be submitted. It was suggested that the rate of issue compared to the rate loaded ought to be reviewed and an update provided. **Carried Forward.** 

#### 2. Discussion

MC asked about an action she believed was agreed, to provide information to Ofgem on LSP AQs not calculating. She felt this was agreed to evaluate performance of Shippers and would provide evidence that there is a need for the modification. CW asked if this information would also be needed for SSP.

Action 0401: Shippers to provide reasons why AQ are not calculating for LSPs.

Action 0402: Xoserve to provide performance of AQ calculations anonymously by Shipper

It was noted that the above actions would provide additional information to support the modification; members agreed completing the actions need not hold up the completion of the Workgroup Report for the June Panel.

GW asked about the reading performance stated in the modification it was noted that a change would be required to reflect 100% within 24 months. GW also asked if Scottish Power had undertaken any analysis that the 85% AQ performance target is achievable if the UNC obligations for reads are met, he wondered if there could be a scenario where the 70% read target was met but the 85% AQ target could not be achieved. He wished to be assured that the 85% AQ target was achievable.

Action 0403: Scottish Power to ensure the 85% AQ target can be achieved considering UNC obligation to provide reads.
