#### **1.0** Review of Minutes and Actions from previous meeting

#### 1.1. Minutes

The minutes of the previous meeting were accepted.

#### 2.0 Discussion / Workgroup Report

AM confirmed a letter will be provided to clarify the key terms in the Meter Asset Provider (MAP) contract, he explained there will be MAP contracts with confidentially agreements. The contract will require MAPs to obtain the data through other routes available in the first instance. If a confidentially agreement is not in place the MAP contract would be terminated.

SM was unsure about consequential liability for the misuse of any data. AJ explained that the MAP would not be aware of the registered user, so any request could obtain information.

SM was concerned that a MAP could use the process to mine data. AM challenged the concerns of a MAP obtaining an MPRN with a meter serial number, he explained parties can obtain the information from other sources ie. The Meter Point Enquiry Service.

AM confirmed that all of the requests from the MAP to obtain the Supplier ID must provide the MPRN and meter serial number, where the MRPN or meter serial number does not match no information will be provided for over 11 cubic meters. For sites with under 11 cubic meters if the asset data does not match the MAP will be supplied the supplier ID and other information as listed in the modification.

AJ was concerned about the access to data for under 11 cubic meters. AM confirmed that the modification could be amended for all sites to have a level playing field, where sites with under or over 11 cubic meters could not obtain the Supplier ID if the MPRN and meter serial number does not match.

AM confirmed that the provision of MAP portfolio can and will be compared.

AM provided a presentation on the results of undertaking a MAP portfolio check.

AM confirmed that there was no evidence of meter serial numbers being made up. Of the 19967 MRPNs checked 12029 had an exact match. He explained no "fuzzy matching" had been undertaken to see if more could be matched for example by a missing digit, he anticipated that a number could have been matched with a "fuzzy logic match".

AM confirmed that he would provide an amended modification for review by the proposer. EM confirmed legal text would be provided, with the aim to conclude the Workgroup Report at the 13 November Workgroup.

If necessary the Workgroup could organise a teleconference following 13 November meeting to finalise the report.
