#### 1. Review of Minutes and Actions from previous meeting

#### 2. Discussion

#### Xoserve Validation

DA provided a presentation on the anticipated validation process and data provision. DA explained the additional information required by Xoserve to undertake the validation of claims and provided flow diagrams to illustrate the process.

MC enquired about the possibility of an audit or assessment of the process to ensure the accuracy of claims. SM compared the process to the Measurement Errors operated by the Distribution Networks.

Costs

GE explained that the modification had been changed to be a User Pays process funded entirely by Shippers.

DA suggested an operational cost would be incurred for each claim, which should be considered.

#### Amended Modification

GE briefly explained some changes he wished to make to the modification, providing a marked up version.

DA enquired about Manifest errors and the likely data that would be provided. He was concerned about the complexity and ability to understand the data. SM envisaged that where Xoserve were not able to interpret the data provided the submitter could clarify it.

AC commented that in some instances where the nature of the error is complex, Xoserve may not have the expertise to verify the base data and the assumptions made in the calculation of the error. It was expected that the base data provided to Xoserve would have to be accepted on face value.

BV expressed concern about the use of the neutrality pot, NTS believed this was not a suitable mechanism for this type of adjustment. BV believed that the use of the neutrality pot is simply shifting the problem and not resolving it.

#### Legal Text

GE clarified the modification could result in a credit or a debit. AC explained that an assumption had been made that the modification would only result in credits and would need to amend the text.

GE explained some further amendments were required to the modification in addition to those highlighted earlier. AC confirmed that National Grid would consider the amendments and review the changes required to the legal text.

#### 3. Workgroup Report

The Workgroup considered the Workgroup Report. It was noted that the Workgroup was due to report in February. The Workgroup recommended that more time should be requested to consider the modification.
