BF explained that following Panel consideration the Self-Governance status had been withdrawn and the modification returned to Workgroup, for further assessment. DM confirmed that the business rules and legal text were recently amended following comments received at Panel.

The Workgroup assessed the text as follows:

Paragraph 2.12.1 and whether the reference to supplier should actually refer to the relevant supplier.

Paragraph 2.12.3 and whether the February 2014 could be achieved. An alternate date was considered, May 2014 was considered a more suitable date for this gas year. The Workgroup recognised that a change from February to May would also impact the Workgroup's implementation plan and this would need to be reviewed. DM agreed to consider this change to the text.

Paragraph 2.12.7 and the use of the term reconcile and whether in reality the action is to simply compare the Users Supply Portfolios.

Paragraph 2.13.1 again considered the use of the term relevant Supplier, it was understood it referred to the relevance of the report to the User.

Paragraph 2.13.4 (d) and the requirement for further clarification where two suppliers appear to own the site.

Paragraph 2.13.4 (a) and (b) should be cross-referenced.

Paragraph 2.13.14 rewording and clarity.

Action 0901: Xoserve to provide the Workgroup with the UK Link defined rules to provide clarity around the provision and content of Reconciliation Reports.
