#### 2. Discussion

DA provided a brief summary of the Blank MAM id age profile data. He confirmed that this data could be provided to the SPAA members and was willing to provide a summary position to indicate the scale of Blank Ids individually to Shippers for those who are paying for this service. DA had some concerns with reporting this information to the SPAA expert group due to the ability to identify Shippers.

It was recognised that this change to SPAA would prevent the future removal of MAM ids but would be dependent on Shippers addressing existing blank ids.

AJ enquired what the management of MAM ids within the reconfirmation process and if the system would remove the MAM id. DA explained that this had been discussed at the SPAA expert group. The process would, no matter the circumstances, not remove the MAM id, the current id would remain in place.

AM confirmed that British Gas were currently reviewing the position of the back population of Blank MAM ids as this change would not address historical removals. It was recognised Shippers will need to address historical Blank MAM ids and that the industry would need to monitor the progress being made and consider any necessary actions to improve this. It was suggested SPAA might need to review how the backlog of Blank Ids needs to be addressed.
