1.0 Introduction and Status Review

1.1. Minutes

The minutes of the previous meeting were accepted.

2.0 Workgroup Report

Various sections of the draft Workgroup Report were reviewed.

Legal Text

It was noted that the legal text had been considered at the previous meeting and that the paragraphing conventions still required revision.

DA reported that Xoserve had identified a query relating to Initial Capacity Reduction (referred in paragraph 5.1.A.4) that it would discuss further with National Grid Distribution, and illustrated the detail (ie multiple steps down and reversing level of final step) on a flipchart. Xoserve needed to assure that its interpretation reflected the intent/expectation of the modification. CW believed this would have no impact and the modification was unlikely to be amended.

Relevant Objectives

It was considered how the modification would facilitate the relevant objectives, with particular attention being given to (a). Following a brief discussion it was agreed that a strong enough argument could only be made in support of the facilitation of (d), and this would be reflected in the Workgroup Report.

Next Steps

The Workgroup Report will be finalised, noting that text may be reviewed based on comments from Xoserve, and will be submitted to the September UNC Modification Panel for its consideration.
