1.0 Review of Minutes

The minutes of the previous meeting were accepted.

2.0 Discussion

Review of Proposed Amendments to the Modification

FH explained that the modification had been revised in line with points raised at the previous meeting, including refining defined terms.

The Business Rules were reviewed. It was noted that 'Interconnector' was not a defined term within the UNC. The interactions of the surrender, reduction and allocation were briefly considered together with hierarchies of use. It was noted that the ExCR Methodology Statement would require modification.

Legal Text

FH briefly explained the structure of the legal text and the additions it would be making to the UNC.

TPD B 2.1.15 – It was suggested that 'Certain...' be removed.

Due to time constraints it was agreed to defer in depth review until the next meeting; any concerns in the meantime should be provided to FH for consideration.

Workgroup Report

TD questioned if issues of discrimination at entry points should be considered. Was an early policy view from Ofgem required on this area? The Workgroup Report will need to justify the stance taken by the Solution developed and supported by the Workgroup.

Next Steps

The Modification and legal text would be revised in light of the Workgroup's discussions. At the next meeting it was intended to review and complete the Workgroup Report, ready for submission to the July UNC Modification Panel. Depending on the readiness of the revised documents this might be held either on Tuesday 25 June 2013, or as part of the next Transmission Workgroup on Thursday 04 July 2013. Details will be notified when progress and arrangements have been confirmed.
