# 2.0 Discussion

Outstanding issues relating to taking capacity away from the market had taken place with Energy UK and Ofgem, and National Grid NTS will be looking to introduce a PARCA window into the modification, thereby providing further opportunities and addressing any competition issues. Other issues regarding holding capacity away from the market for a length of time (eg unsold capacity being taken away from the QSEC process when not being competed for) remain under discussion.

## 2.1 National Grid's Capacity Methodology Statements – Impacts

MW gave a presentation. National Grid NTS was continuing to work closely with Ofgem. There were 5 statements and changes to these were being minimised as far as possible. MW explained in more detail and summarised the changes required in each area. Existing ARCAs will run their course and no new ones will be agreed once the PARCA becomes the accepted vehicle.

### Entry and Exit Capacity Release

It was confirmed there would be a list of Revenue Drivers in the Licence.

The 01 October date was to allow two build seasons (24 – 35 months).

Referring to the second NPV test and price step changes, TD questioned what would happen if the NPV test is failed at that stage; is there a risk from a developer's perspective? MW noted this for further consideration.

### Consultation Timetable for changes

A high level timetable was outlined. MW encouraged those present to provide feedback on the principles and indicated that some documents would be published over the next few weeks. A formal consultation would follow an informal one; the PARCA one would be in addition to the one for RIIO.

### 2.2 Next Steps

At the next meeting it is intended to consider the revised modification and any changes to the Methodology Statements as well as stepping through the pricing and interactive scenarios as required.
