1.0 Review of Minutes and Actions

1.1 Minutes

The minutes of the previous meeting were accepted.

1.2 Actions

1102: All parties to review the draft legal text and provide their views at the next Workgroup meeting.

Update: DA confirmed that final text had now been provided with an amended modification. See item 2.0. **Complete.**

2.0 Legal Text

The Workgroup considered the Legal Text provided by Scotia Gas Networks as requested by the Panel. DM explained the inserts, new definitions and new sections as required.

The Workgroup recognised that Modification 0428 would affect some of the sections and definitions and that SGN needed to review the text if this modification was likely to be implemented post 01 April 2014.

DA agreed to consider some further changes to the text.

HCh advised that Xoserve intended to charge customers all year round and provide a rebate for the non-summer months. HCh was uncertain if this would be based on a new customer charge type. BF enquired if the use of a new customer type would impact the charging statements.

Action 0201: Transporters/Xoserve to consider any impacts to charging statements for a new customer type.

BF enquired about reduced use gas and whether this service would be made available for customers who wish to use gas to heat offices in the winter months and have a separate need for a seasonal gas service in the summer. DA agreed to provide clarification.

CW highlighted that text may impact the post implementation Project Nexus text.

CB challenged the User Pays element of the modification and the analysis, which suggested that there were no existing customers who had the consumption pattern to take up such a service. BF recommended SGN consider the User Pays section in the modification and identify how the costs are apportioned.

DA agreed to amend the modification and Legal text in preparation for the next Workgroup Meeting.

3.0 Workgroup Report

Subject to the provision of an amended modification and legal text being amended the Workgroup hoped to consider and finalise the Workgroup Report on 27 February.
