MJ advised that the modification had been recently amended to reflect discussions at the previous Workgroup meeting.

#### 3.0 Workgroup Report

During a brief review of the (draft) WGR (v0.4, dated 26 November 2013), it was noted that the report reflected the latest modification changes before DM provided a brief overview of the legal text and confirmed that this is formal text. DA advised that with regards to the proposed changes to TPDG 1.10, Xoserve currently hold two calendars – an SPA and a non SPA version.

BF suggested that it would be beneficial to look to amend the modification to include a list that identifies which potential processes fall under Business Day / non Business Day, as a consequence of implementing the modification.

CW suggested that Section 3 of the modification should be amended to add further clarity around the fact that 02 January would be a Business Day for SPA system purposes only.

In reviewing the User Pays table, those present indicated that they were happy to agree that this is not a UP modification, whilst DA pointed out that Xoserve are looking to retain some manual processes for the non Business Day aspects (i.e. referrals etc.).

Moving on to briefly discuss the implementation aspects, DA confirmed that in his opinion there would be no potential Network Code Modification 565 'Transco Proposal for Revision of Network Code Standards of Service', impacts associated with the implementation of the modification. BF suggested that as this is a self-governance modification, it may be beneficial to amend the modification to also reflect the latest version of the WGR which would be published after the meeting.

Concluding, MJ indicated that he would now amend the modification to reflect today's discussions.

The Workgroup indicated that they were happy to proceed with the Workgroup Report, subject to receipt of the amended modification in due course.
