1.0 Review of Minutes and Actions

1.1. Minutes

Minutes accepted.

1.2. Actions

0301: National Grid to provide potential indicative service cost charges for a within day Meter Read service.

Update: CW explained it would be difficult to provide an indicative service cost charge at present. SM expressed concern that it would be difficult to benchmark commercial services without an indicative price for providing the data in a similar way to what is provided now. It was agreed that a New Issue should be raised through the Distribution Workgroup to pick up this item so it does not delay the development of Modification 0466. **Closed.**

2.0 Discussion

CW confirmed an amended modification and legal text had been provided.

AR summarised the changes to the modification. DA explained that there are some complexities with the forthcoming gas day changes. The modification had been changed to work towards providing reads by 12:00 and liability being paid if they were not provided by 14:00.

CB expressed concern about the D+4 read provision service delivery and the impact on Shippers. CB explained that closing out on the wrong value could cause a significant impact on allocation costs and settlement. This also causes an issue with the system defaulting to a D-7 estimate. SM highlighted the issues surrounding consequential loss. CB believed that the incentive regime had been developed to incentivise Transporters to achieve delivery and that reducing the incentive for a service that has a much higher financial impact to Shippers was not acceptable without justification. CB was uncomfortable reducing the payment down whilst Transporters are not achieving the target consistently. CB was also concerned about the impact of the change to business days, this could potentially impact sites that operate 24/7 as it would exclude weekends and Bank Holidays.

AR agreed to review the modification in relation to the performance incentive and how the industry could move away from the £75 incentive payment once Transporters were able to demonstrate performance achievements. He believed the industry could make a stepped change towards the reduction to £50 or lower once the new technology was rolled out.

3.0 Legal Text

Further to discussing the incentive regime it was recognised that the Legal Text would require further amendment.

It was anticipated that the legal text would be provided for consideration in time for the next meeting.

The Workgroup reviewed and updated the Workgroup Report.
