2.1. Consideration of whether or not NTS telemetry equipment is considered to be Daily Read Equipment and therefore impacted by IX communications

MC provided National Grid NTS' view that telemetry equipment falls outside of the scope of this modification. He advised that the legal advice he had received from National Grid's legal team supported this view. GE discussed what was currently provided with MC who agreed to look into the granularity of the information that was available. GE agreed that he was happy to accept that the equipment was not in scope, providing that the information/data was suitable in it its content and availability. He was also comfortable that National Grid NTS would not need to adopt the requirement to provide data via IX if they currently used a different delivery system. BF summed up the discussion as the issue being the definition of the term "daily read". MC agreed to provide a definitive view of the granularity and frequency of the provision of the information that was available.
