**0601:** DNs and Xoserve (DA) to investigate the feasibility of providing a more detailed breakdown (including being able to set as 'capped off' or 'meter removed', etc) of the reporting data items and provide a view in due course.

**Update:** DA reported that this had been discussed with the DNs, and that preliminary investigations regarding requirements were ongoing. It was suggested that if any party had further information in respect of data items about which there might be concerns about reporting then these should be communicated to DA. **Carried forward**

**2.0 Workgroup Report**

The Workgroup Report is due for submission to the November UNC Modification Panel.

## 2.1. Data Item Reporting

AM explained it might be difficult to distinguish between certain data items and these may have to be merged, but this would still provide Shippers with a reasonable level of granularity. Failure to split out data items will create a lot more work to identify any related errors. DA observed that further splitting may not be possible in terms of the UNC - Xoserve was unable to determine the accuracy of indicators and would have to rely on other factors being maintained and kept up to date. Xoserve would not be comfortable inferring whether something might be, for example plastic pipe, as replacement information is not available to them, and Xoserve would not be able to provide anything very meaningful.

AM and DA will discuss further before revising the modification.

## 2.2. Legal Text Preparation

The legal text for this modification is to be provided by National Grid Distribution.

CW indicated that preparation of the legal text would commence once the modification has been revised.
