GE confirmed the service was for DN customers only and NTS direct connects were out of scope. **Carried Forward.**

Action 1202: Transporter to seek a view from their operational colleagues on the plausibility of managing the process and provide any alternative approaches.

Update: DM, AR and AJ had some reservations how the process would work in practise. There is a danger of raising customer expectations beyond what could be achieved in reality. **Closed.**

Update: Workgroup agreed to close action. Closed.

CB was concerned about raising customer expectations by implying such a service is available when it may not always be.
