#### 1.0 Outline of Modification

UNC 471S Amending the start time that a Day-ahead Market Offer can be accepted presentation

Reviewing the presentation, NR advised that the November Panel had approved self-governance status for the modification on the grounds that it involves minimal change.

HB indicated that whilst National Grid NTS had had some initial reservations relating to trade nominations, these had been resolved following a discussion with the proposer.

When asked, NR indicated that she would be happy for the modification to progress further based on the initial cost predictions rather than requesting a ROM at this time.

## 2.0 Initial Discussion

Completion of Workgroup Report

During an onscreen review of the draft Workgroup Report (v0.2, dated 05 December 2013), various amendments were made by LJ in response to discussions around the table.

TD pointed out that at the November Panel, National Grid NTS had voiced concerns around certain aspects of the modification. Responding, HB reiterated that following discussions with the proposer, National grid NTS are now happy for the modification to proceed.

In examining the User Pays table, NR confirmed that EDF Energy proposes an equal split of costs between Shipper and Trader Users based on their respective throughputs. In briefly discussing what is truly meant by the term 'throughput', MC provided a brief explanation of the Xoserve definition whilst LJ continued to amend the WGR wording in line with the discussions – it was agreed that keeping consistent with the Xoserve definition would be beneficial. Views remained divided as to whether or not the charges would apply to both Shippers and Trader Users – in the end it was agreed to keep as both. TD questioned whether the amendments to the UP table potentially conflicted with the Relevant Objectives as currently written. A request was placed on Xoserve (DA) to look to provide a supporting ACS by close of play on Friday 06 December to accompany the WGR.¹ When asked, TD suggested that it would be likely that without an accompanying ACS, the Panel would not be inclined to send the modification out to consultation.

During a debate on the Relevant Objectives, NR agreed that the reference to objectives a) and b) could be removed as there were doubts voiced as to whether or not there would be any benefits involved.

In reviewing the implementation statement, LJ made some onscreen changes to reflect discussions and Xoserve (DA) agreed to provide an implementation timeline, along with a supporting indication of costs (but not an actual ROM per se) by no later than the end of January 2014.

Moving on to consider the legal text, HB confirmed that she would confirm the legal text status (i.e. as final legal text) in an email to the Joint Office on Friday 06 December. NR then advised that she would now amend the modification to align with the changes prescribed within the WGR.<sup>2</sup>

In concluding discussions, the Workgroup approved the report, as amended for submission to the 19 December Panel.
