#### 1.0 Review of Minutes and Actions

#### 1.1. Minutes

AL proposed amendments to the 24 March 2015 minutes. Thereafter, the minutes of the previous meeting were approved.

### 1.2. Actions

**0506 1101:** Xoserve (EL) to investigate the areas of concern with regards to manual workarounds.

**Update:** EL requested that the action be carried forward until the next meeting. Discussion took place with AL, EL and CB concerning changes to consumption and the use of the consumption adjustment process should retrospective adjustments be de scoped from Project Nexus delivery. EL explained that it is proposed that the current process is continued into the new regime until retrospective adjustments can be implemented. A number of participants were concerned about the continued use of the existing process, as there were no rules in place to fit the new regime. AM advised the process is underway to get industry views on retrospective adjustments and commented that energy is not validated but all other aspects are will be validated as now. **Carried Forward**

**0506 0305:** Wales & West Utilities (RP) to discuss with lawyers on how any legal text would look to bring the iGTs into the Performance Assurance Framework Regime. **Carried forward**

**0506 0306:** Reference draft 0506 Guidelines Document – Scottish Power (AL) to consider whether an iGT UNC Modification is required to include the iGTs within the Performance Assurance Framework Regime. **Carried Forward** 

**Update:** AL mentioned she was not sure why Modification 0506 and 0506A would be different in this aspect and has raised it with iGT's so that they were aware that they may be impacted. She was unsure why 0506 would require a modification to the iGT UNC but 0506A wouldn't. AM thought it was likely due to where the regime was pointing in each modification – 0506 appeared to be pointing towards the physical meter point downstream of the CSEP whereas 0506A was concerned with information at the CSEP which was within UNC. AL is to review and respond accordingly.
