### 4. Any Other Business

4.1.

A question was raised whether there ought to be a process for when Transporters are transferring or buying assets from other Transporters or iGTs.

AR explained National Grid had purchased assets from an iGT. However, Shipper's believed the iGT was still trying to bill for a service they no longer provided. CB was keen to understand from the Transporters the effective date of the transfer. It was agreed that the transfer process from an iGT to the Transporter needed to be considered to ensure efficient tidying up of system information and appropriate billing.

AW explained that there is a licence obligation based on the disposal of assets. He suggested that this might need to be reviewed if the transfer has not been clean. It was recognised in this instance the transfer only involved thirty customers, however there was some concern about the process particularly the need for more much tighter control.

It was agreed that National Grid Distribution would liaise with the iGT and Shippers to address the situation and establish the correct transfer date.
