This also includes concerns around outages, which would prevent the standard detailed from being achieved. In response DA advised that this year the AQ outage lasted 31 hours and he expected this would have been taken into account when that section had been drafted.

Participants discussed this with the proposer and the Transporter agreeing they were happy with them being present.

DA confirmed that Xoserve did not envisage any problems as the purpose of this modification was only to correct an existing error where the UNC stipulates that the data for the transfer of ownership within UK Link is released at D-7 and the trigger for this in the current system will only release the asset data at D-2.
