The Workgroup Report is due to be presented at the UNC Modification Panel by 20 November 2014.

1.0 Outline of Modification

CW introduced the modification and explained the intent to address the timing of meter asset data provision so Transporters do not send the asset data until the objection deadline at least 2 system business days prior to the transfer of ownership. This would correct an anomaly introduced by the implementation of Modification 0477 Faster Switching.

2.0 Initial Discussion

The Workgroup considered the required amendment to Section M3.2.9.

'In respect of a Supply Meter Point comprised in a Proposed Supply Point in respect of which the Supply Point Confirmation has become effective, the Transporter will provide to the proposing User the Meter information (as held on the Supply Point Register) on the 7th 2nd Supply Point Systems Business Day before the Proposed Supply Point Registration Date in 90% of instances and in any case on the Proposed Supply Point Registration Date in 100% of cases.'

CB enquired about the insertion of a service level provision and the impact of this pre and post Nexus.

AJ challenged the need for the modification. She questioned if there were any perceived issues with providing the incoming Shippers a set of meter asset data details if the transfer of ownership maybe objected to and the site may not actually transfer ownership.

DA confirmed that the UNC stipulates that the data is released at D-7 however the way the actual system will work and the triggers for the transfer of ownership within UK Link will only release the asset data at D-2.

All parties agreed to consider their own system capabilities in light of the intent of Modification 0477 (ie release asset data at D-2) and report back next month.

Action 0901: All parties to consider their own system capability to manage the appropriate data flows.
