#### 1.0 Review of Minutes (28 January 2016)

The minutes were approved.

### 2.0 Cost of the Solution option(s) and associated costs/benefits

BF explained that a late draft amended Modification had been received for discussion. CB apologised for the lateness of this amendment and explained that she had been working with Xoserve and the Association of Meter Operators (AMO) regarding the information that was to be provided at Postcode Level by Transporters, including the availability of the this information to industry parties via the MAMCoP list. She explained the 'post Nexus and interim' solutions had now been removed, so there was now just one overall solution. She explained the spread sheet would include the specific information regarding the meter point pressure, which did not remove the GT1 process entirely, however, this did now reduce the workload. The list is to be refreshed and published quarterly and the dates for this would be up to GT's, as they would supply the information to Xoserve.

BF explained due the lateness of the amended Modification it was advisable to discuss this further at a Teleconference to be held on Friday 04 March 2016 at 10.00am. He also

proposed that it still might have to be deferred to the April Panel, if the Legal Text was not completed in time.

SM asked CB whether this modification was still required and CB stated that yes it was as the information could be useful for Shippers and the modification created an obligation rather than relying on an informal arrangement. CB felt that it was capable of being Self Governance and this should be reflected in the report.

HC sought clarification regarding the overall access and whether it would include the MAMs, Shippers and Suppliers, as that would be a very large distribution list. CB confirmed this was correct, for all 3 groups to have access.
