## 1.0 Outline of Modification

LJ introduced the modification and explained that, whilst it does not propose any changes to the Uniform Network Code because any amendments would be restricted to the Interconnection Agreement only, it does involves a set of quite technical changes.

#### 2.0 Initial Discussion

# 2.1. Completion of Workgroup Report

The Workgroup undertook an onscreen review of the draft Workgroup Report (v0.1), during which the main discussions points were captured, as follows:

#### Section 3 - Solution

ML explained that the proposed changes within the table form what is in essence a tidy up exercise and even though the Gas Entry provisions are linked to Code, these proposed amendments do not change how parties operate.

LJ pointed out that as it is proposed that the Workgroup Report is completed at today's meeting for formal submission to the April Panel, and thereafter out to consultation, any questions should be raised now.

When asked, ML confirmed that COS (Carbonyl Sulphide) is already defined within the Interconnection Agreement.

LJ made some onscreen changes in response to a point around the use of the terms 'sulphur' and 'sulphide'.

When asked whether or not the modification would be expected to affect any sources of gas, RS responded and explained that in short the answer is no, as no changes are proposed to the existing gas operational and sourcing aspects (i.e. gas quality etc.).

#### Section 4 - Relevant Objectives

At the request of NR, relevant objective g) was added to the statement sitting after the table to read as '.....either positive or negative, on relevant objectives (a) to (e) and (g)'.

When asked, those in attendance approved the Workgroup Report, as amended.

# 3.0 Next Steps

Concluding discussions, LJ explained that the Workgroup Report would now be submitted to the April Panel with a recommendation that it is issued direct to consultation with a view to thereafter being considered at the June Panel for a decision.
