1.0 Review of Minutes and Actions

1.1. Minutes from the previous meeting were approved

1.2. Actions

Action 0201: National Grid Distribution (CW) to provide further information with regards to ratchet charges.

Update: CW confirmed this action could now be closed as this matter had already been addressed. **Closed**

Action 0104: HC to investigate putting User Pays on all queries within the Xoserve process.

Update: HC confirmed this action could now be closed at this matter had already been resolved. **Closed**

2.0 Workgroup Report

2.1. Amended Modification

SM explained that Modification 0551 had been amended, mainly focused on clarifying the Business Rules as had been discussed. There were no material changes with regards to the remainder of the wording and SM confirmed that NTS sites were excluded. JF agreed that this version did not present any issues with regards to the drafting of the legal text. FH stated that since the modification was associated to the Meter Point Reference Number, which would effectively remove NTS sites from scope, then that would be acceptable.

SM had a question regarding the raising of a query in relation to the 5 day time period specified in Business Rule 4, specifically in the circumstance of the process taking longer than 5 days. HC clarified that queries had to be raised within the D+5 time window. JF agreed that it was not advisable or an option to alter the existing arrangements. General discussion took place, eventually focussing on Christmas and Easter Holiday periods. It was agreed that DA and JF should look at this area, specifically regarding how to manage the query window within 5 days and the timed out period over the Christmas and Easter periods such that the Business Rules can be confirmed

New Action 0901: DA and JF to investigate how to manage the query window within the 5 day window and confirm any further BR4 amendments to SM.

2.2 Completion of Workgroup Report

JF advised that Legal Text had not been prepared at this time but was confident that the Business Rules were now robust enough to carry out this work. It was agreed to defer further consideration of the Workgroup Report pending receipt of the Business Rules and Legal Text.

LJ suggested that a further meeting should be held to finalise the Report in order to meet the Panel reporting deadline of October; a Teleconference Call was agreed for 06 October 2015.

3.0 Next Steps

LJ stated that the aim was to conclude the Modification 0551 Workgroup Report at the teleconference meeting to be held on 06 October 2015 – 9.00am – 10.00am.
