1.0 Introduction and Status Review

1.1 Review of Minutes (25 February 2016)

The minutes of the previous meeting were approved.

1.2 Review of Actions

Action 0201: RWE npower (SP) to confirm if the PIA document can be circulated to the Workgroup and why this information is needed, together with if the Suppliers have permission from the Shippers to share information from an MPRN perspective.

Update: SP confirmed the PIA had been released at the end of February 2016, which was marked as confidential and so could not be shared with the Workgroup. She explained the PIA had no impact on other aspects of the modification, so this action could now be closed. **Closed.**

Action 0202: RWE npower (SP) to amend the justification section in the modification once the PIA is available.

Update: SP confirmed the modification had now subsequently been amended so this action could be closed. **Closed**

2.0 Workgroup Report

2.1. Amended Modification

SP confirmed the amendments had been made to the modification and she had gone through these changes with Experian. She explained Experian would use the data obtained every month, to perform a cross check with the TRAS data, which was required from a Data Protection perspective, to ensure there was no 'data mismatch' or data used that they shouldn't have access too.

A lengthy discussion then ensued surrounding the Data Protection topic and SP confirmed that Experian did have a Data Protection Policy in place. CB requested clarification surrounding the Transporters schedule from a mandatory or voluntary aspect in SPAA schedules, and SP said she would further investigate this aspect further. General discussion then took place regarding the MPRN DVD in relation to the kind of data Experian would be able to access. It was a general consensus that Experian would not have all the required data needed, as there would be 'gaps' in the data, where perhaps Schedule 431 would be more useful. CB was concerned that the providing the data held in transporter systems would not provide additional leads to TRAS as this would highlight to shipperless sites and TRAS would not be able to allocate the lead to a relevant supplier.

Further general discussion took place regarding the 'Crime Stoppers' service and ARS said this was not a direct comparison and DA confirmed this was specifically for GT Data only. SP said it was not feasible to put a data enquiry for Crime Stoppers, in the modification, as it required all the data and not just site specific data. GD asked if the Unique Sites were included in the modification and SP confirmed no, the Unique Sites were excluded from the MPRN DVD.

It was then agreed that SP needed to document the various concerns and that more indepth discussion was still required, specifically in relation to why Experian wanted this level of data and what they would use it for. SP agreed to feedback and would arrange for Experian to present at the next meeting on 28 April 2016, to provide further clarification and understanding to the Workgroup on the data requirements.
