#### 1.0 Introduction and Status Review

#### 1.1. Review of Minutes (26 May 2016)

#### 2.0 Workgroup Report - Review

DF explained he was representing RWE npower on behalf of Edd Hunter. He said that the modification had been presented to Panel 2 months ago and had subsequently been returned regarding the User Pays Section. JF said it had been flagged at Panel due to the incorrect wording within the User Pays section in relation to a Non Code User Pays service, when it had been raised as a permissions modification and so the legal text was not compatible. DF said he was in agreement with the wording being changed and for it to be resubmitted including the amendments. BF said the Workgroup Report would be revised and completed.
