1.0 Introduction and Status Review

1.1. Approval of Minutes (20 December 2016)

The minutes of the previous meeting were approved.

2.0 Amended Modification

MM gave a brief presentation, summarising the key aspects of the proposal reviewed and, issues investigated by the workgroup to date. It was confirmed that the issue of withheld capacity was still the subject of ongoing discussions with Ofgem and, once the options are clearly understood, they would be taken to the Transmission Workgroup for discussion. It is recognised as a separate issue outside of the UNC and that the Incremental Project Proposal would clarify this (consultation in November) if any projects were initiated.

MM went on to explain the minor changes made to footnotes 1 and 2 in the amended modification.

It was also noted that the Authority's decision must be received before the capacity methodology statements can be revised.

3.0 Legal Text and Commentary

MM explained the changes made to the text and a discussion ensued.

EID Section E

Paragraph 5.1.2 - GJ evinced concern regarding the treatment of non-User Applicants (to which the UNC requirements would obviously not apply as such a party would not be a signatory to the UNC). MM explained how such an Applicant would be treated and what rules would apply. Any changes required regarding the treatment of non-User Applicants would be managed through the Project Proposal (MM did not believe anything else could be done without changing the Licence/methodology). The PARCA contract also contains a User Nomination section and other appropriate provisions.

Paragraph 7.1.3 - It was suggested that the word 'all' should be removed, and this was agreed.

MM clarified a number of points (relating to interactions) for JT. CS observed that provisions had been made to cover the main scenarios and that National Grid NTS had considered and taken into account the domestic auctions as best it can to try and avoid potential conflicts of processes.

SJ then summarised the key points relating to EID Section E in the commentary.
