1.0 Outline of Modification

Opening discussions, BF explained that no documents had been provided prior to the meeting.

UNC Modification Proposal 0613 – Revised UK Link Manual CDSP Data Services Document presentation

CW provided a brief overview of the presentation explaining that the modification is seeking to create the UK Link Manual (a CDSP Service Document) as part of the Data Services Contract

(DSC). CW then explained that the industry might also need to raise another modification to change the Framework Agreement in due course.

In explaining that Xoserve has already reviewed a significant portion of the UK Link Manual change requirements, DA pointed out that the Project Nexus and FGO aspects add a level of complexity to the proposed change exercise, especially the UK Link Manual and supporting document hierarchy aspects. Furthermore, the file format and template have increased in both size and complexity.

When BF explained that the UNC Panel have suggested that it is better for the Workgroup to take its time and do the work correctly and look to produce good quality, meaningful documents, DA explained that he would need to discuss the matter with his colleagues before committing to a potential delivery timetable.

When asked whether any proposed changes associated with the modification would fall under the auspices of the new Change Management Committee now that the standalone UK Link Committee no longer exists, BF pointed out that as the modification was raised pre-DSC, its governance is via the UNC route. Responding, DA explained how lower level changes had been managed in the past and Xoserve are currently considering (as a matter of urgency) that perhaps both governance routes should be engaged in order to cover all the bases.
