1. Review of Minutes and Actions from previous meeting

## 0011: 0410A -

a) Provide/publish the relevant section of the draft SPAA CoP; and
b) Read the SPAA Theft of Gas Code of Practice document before the next meeting and assess whether a sufficient degree of assurance in respect of disconnections exists
Update: CW provided an update and suggested changes to Business rule 12. AW believed that the Theft Code of Practice (CoP) was drafted without considering unregistered sites, he questioned if unregistered sites can be classified as theft. CW challenged that offtaking gas without a supplier is in breach of the Gas Act. AM questioned if unregistered sites need to be included in the Theft CoP. CW believed the CoP would need to be updated. However consideration needed to be given to disconnecting customers who can provide evidence of being billed by a supplier. CW explained the process for updating the SPAA CoP. AW was keen for Transporters to make reasonable attempts for customers to obtain a supply and to consider vulnerable customers. CW explained that vulnerable customers are considered within the CoP. AW suggested that the Transporters should consider the Theft CoP and what would apply to unregistered rules. AJ believed the Transporters should not be explicit on reasons why a customer would not be cut-off as the CoP is a public document. The Workgroup considered whether transitional arrangements would be required to the Theft CoP.

AM enquired about the SPAA CoP best practise, CW explained that Transporters are working together to ensure processes are common and that best practise will be followed where it is possible however internal processes may differ slightly. Complete
