#### New Modifications

SM confirmed that Gazprom were considering three DME related modifications and the intention is to raise these for consideration for the next UNC Panel meeting in December. He also confirmed the intention to raise a modification potentially as an alternate to Modification 0428 - Single Meter Supply Points to only include MPRN creations going forward and with grandfather rights for aggregations already in existence.

#### Removal of the January Scottish Bank Holiday

DA enquired, following an enquiry at the UK Link Committee, if there was an intention to remove the January Scottish Bank Holiday and treating this as a normal working day in support of the EU Third Energy Package: 21 day switching requirements considered under Modification 0403. It was agreed that a modification would be required to undertake this change as this was not in the scope of Modification 0403. Scottish Power had no objection to the Bank Holiday being classed a business day.

## Modification 0403 non-business day processing

DA also enquired on behalf of the UK Link Committee about the solution for Modification 0403. He believed that the Workgroup had considered the submission of files on nonbusiness days, he had understood that rather than the extra costs of processing files on non working days, it was accepted that Xoserve would process files received on the next working day to keep costs to a minimum. The Workgroup concurred with this understanding. DA confirmed if there was any further concern expressed at the UK Link committee regarding the processing of files DA advised this would be communicated through the appropriate route.
