4.1. ISS 018, Handling of Emergency Situations at Priority Customer Sites

4.2. ISS 0020, Third Energy Package

BF confirmed Modification 0396 - EU Third package: Three week switching was raised on 08 August 2011 and will be considered on 18 August 2011 by the Panel. It was agreed that initial discussions would take place on 07 September 2011, and that this Issue was now closed.

4.3. ISS 0028, Status of new connections prior to the completion of reinforcement of the AQ table

In the absence of JM, CT will seek to provide an update.

5. Any Other Business

5.1 Proposal to amend Annex A of the CSEP NExA table, by replacing the current version of the AQ table

BF advised that this had been raised as new Modification 0392, for consideration by the August UNC Modification Panel.

CW had concerns regarding the proposer's indication that this might be a selfgovernance modification. He pointed out there was an iGT impact and in his view self-governance would not be an appropriate route. KK confirmed that an iGT modification had also been raised.

GE questioned the derivation of the numbers in the Table; ST pointed out that these were not from the iGT world; SND Values work is carried out under the Demand Estimation Sub Committee (DESC).

MJ explained how Modification 0392 differed to previous similar modifications that had been rejected by Ofgem; CW observed that these differences needed to be made extremely clear to reduce the risk of rejection.

KK agreed to consider requesting Panel to send the modification for assessment rather than straight to consultation.
