### 4.2 Modifications 0395 / 0398

AW advised that Ofgem had written to the industry advising of a minded to implement for Modification 0395 and to reject Modification 0398 and that they have requested responses to the letter by 25 January 2013.

CW advised that should Modification 0395 be directed for implementation, a significant amount of preparation work would be required ahead of implementation and that this would need to be discussed in an appropriate forum.
