#### 2. Modifications

## 2.1 Modification 0335 - Offtake Metering Error - Payment Timescales

BF reminded members that this modification proceeds under the old rules.

Commentary in association with the legal text is expected to be available for review and discussion at the Workgroup meeting on 07 September 2011.

#### Completion of Workgroup Report

The group discussed the relevant objectives together with the advantages and disadvantages. In respect of relevant objective (b) DC confirmed that although the Shrinkage Manager recognised an indirect benefit it was not of sufficient significance to warrant identification as such under this section, but there may be value in including it as an advantage.

The element of retrospectivity was considered and aspects were clarified. JF highlighted the complexities identified regarding invoicing and billing in relation to Transporters' systems, and observed that an additional contractual risk had been identified in relation to the Distribution Network Owners; the risks on various parties were briefly debated. The views expressed by various parties present were included in the Report as the discussions progressed.

The Workgroup did not recommend that the Panel request the preparation of legal text.

In the meantime the Report will be published on the Joint Office website and will submitted to Panel unless further issues are raised at the meeting on 07 September 2011, following the review of the legal text and commentary.

Action Dis0809: 0335 – Review draft Workgroup Report and submit comments to Joint Office in advance of the 07 September 2011 meeting.

DW indicated that, once 0335 had been issued for consultation, he was minded to raise an alternative proposal. This would reflect much of 0335 but with key differences in that the solution would apply to all Offtake Measurement Errors, and it would be seeking to align the repayment period with the Shrinkage credit period.

## 5. Any Other Business

# 5.1 Modification 0395 – Limitation on Retrospective Invoicing and Invoice Correction

The initial meeting has been arranged for Monday 12 September 2011 via teleconference, commencing at 09:30.

SL outlined the objective of the modification and gave an overview of the electricity arrangements for comparison purposes. The impacts on annual sites with different reading arrangements were illustrated and briefly discussed. BD pointed out that MAMs were able to make adjustments, and LW pointed out that billing adjustments could still be made. SL requested a list of potential adjustments/causes be made available at the meeting on 12 September 2011.

SL believed that this was something that Shippers can and should manage.

Action Dis0810: 0395 – Provide a list of potential invoice adjustments/causes for 0395 meeting on 12 September 2011.

Action Dis0811: 0395 – Establish the potential adjustment LSP volume on monthly and daily read sites.

LW believed that the question was, how close is allocation to reconciliation in aggregate, as any errors should balance out.

SL observed that USRVs were decreasing at approximately 30 per month, and at implementation this would be expected to have reduced to around 200. A general review of the USRV process was outside the scope of the modification.

He would be happy to bring down 152 to 20 months if that was more desirable. JF felt that it was better to tackle the USRV issue by shortening the date.

There was a need to quantify Must Read impacts and it was suggested that an idea of the number of must reads actioned on monthly basis for the previous 24 months would be useful.

Action Dis0812: 0395 – Establish the number of must reads actioned on monthly basis for the previous 24 months.

SL had identified other issues to be considered, such as what settlement period should the industry be aiming for, and was there any impact on credit/securitisation issues (can these be quantified?). Identification of any other issues would be welcome.

The intention was to achieve a 01 April 2012 implementation date and SL asked if Xoserve could establish what notice from Ofgem was required.

# Action Dis0813: 0395 – 01 April 2012 implementation date - Establish what notice from Ofgem was required.

BF confirmed that the Terms of Reference had been published and drew attention to the additional items for consideration suggested by Panel. Any comments would be welcome in advance of the meeting on 12 September 2012.
