2. Issues

2.1 0186 - Provision of Cost Information

WG provided an overview of NGNs 0186 information in a revised format more akin to that provided under the DCUSA, as discussed during the previous meeting. He emphasised that specific incentive details have been omitted due to potential commercial sensitivity issues. The DNs confirmed that they believed the suggested changes to the 0186 report formats could be accommodated without the need for a UNC Modification.

AM asked if, given its significance, shrinkage could be highlighted separately within the report. WG had concerns that this could lead to inadvertently revealing commercially sensitive information regarding other incentives. This was a concern shared by DA, although he did point out that the information provided for Modification 0386 "Smoothing of Distribution Charge Variation" included historic shrinkage data. JE advised that the WWU 0186 report already shows separate shrinkage information.

Shippers welcomed the revised format, feeling it added information and clarity. They will consider the format further and provide any additional feedback at subsequent meetings.
